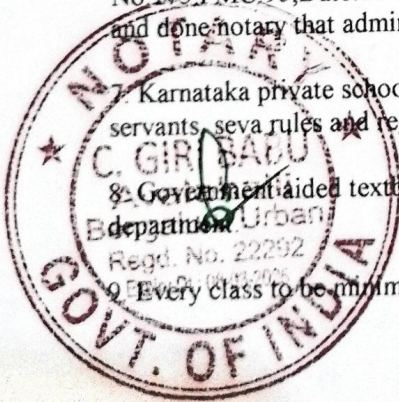
1. Registered Rule under 3[5][4].
2. Under Governing councils Rule 4[4], the terms and Conditions are mentioned are mandatory.
3. School plan, valuation, building, equipment's, faculties, and economic facilities is mentioned under conditions. There is no permission granted by the government to open the branches by the school.
4. School should be opened by the government permitted language and government allocated land only. School should not alliance with any other school trusteeship . and should be maintained by the government allotted land and government allotted name and same trusteeship.
5. This education society should maintain Governments rules whenever the rules are published to all education societies. As per Karnataka education Amendment 1983 [Karnataka acts No.1:96] in this all acts and which rules in this act should be followed .

6. Parmanent funds Is granted to respective registered High School under government notification No.175/PMC/95, Date: 07-09- 1998 to 29-12-998 . School administrative has declared the same in Rs.10 Stamp paper and done notary that administrative of the school is not expecting any funds from the government.

7. Karnataka private school institutions [private granted primary and high school institutions government recruited servants, seva rules and regulations] to be followed under rule 1999 mandatory.

8. Government aided textbooks and Examinations procedures to be followed as instructed by the education

9. Every class to be minimum of 25% of attendance

10. Educated faculties to be appointed as per the department rules and regulations. All schools registered by under Karnataka education amendment Article 8th, Sub article 36-39 the registered comes under temporary recognized under prevalence.

11. All students should be medically tested every year according to rules and regulations.

12. School administrative to do security deposit in district sub-director and administrative joint account.

13. Requirements of school equipment's, stationaries, library, books, playing area, school building and other facilities should require within one year. If it is failed the Order which has given cancelled automatically.

14. School opening and students attendance information to be submitted within three months of schools academic year to the office. if in case the school is not opened in time and rules is not followed then the order is cancelled automatically.

15. Washrooms and Restrooms to be constructed separately for the Boys students and Girls students, and Drinking water facility is required.

16. Initial recognition is submitted to the sub-director, under sub-director education act, and governments order dated:30-09-2007, school should get information from rule -3, check list and submit the initial recognition with in the 3 months without fail, if not, registration canceled automatically.

17. Schools building, fire, electricity and other incidents should not be happen, and to be examined regularly, and advertisement of prohibition of tobacco shops and illegal activities surrounding 100 meters of school area, to be displayed in front of the school.

18. If school administrative gives false information, Department has the rights to cancel the Registration of the school.

19. Governments notification No.ED 369,P.G.C 2014,Dated:11.11.201 and office notified dated:14.11.2014 rules and regulations to be followed.

20. Governments notification No.ED 709,P.G.C 2017,Dated:07.03.2018 and office notified dated:26.03.2018 rules and regulations to be followed.
