Conditions:

1. In accordance with the Child Rights Education Act, 2009, and the Karnataka Education Act, 1983 and the rules made thereunder. Register the school, the accreditation is updated up to the class registered. Apart from these classes, additional classes and extra sections are not permitted.



2. The school is governed by the Karnataka Education Act 1983 and the Child Rights Education Act 2009 under the rules framed thereunder Acting .

3. Child Rights Education Act 2009 to reserve 25% seats for weaker section children under the rules framed thereunder. Government has the authority to enrol under RTE reserved seats for schools covered by RTE. [Government has made rules to facilitate the enrolment of children in neighbouring schools where their parents live, according to which, if there are government and government-funded educational institutions, children will be enrolled in that school) Otherwise, private schools will enrol children enrolled by the government and allow them to continue their education up to the primary level. To enable these children to continue their education without any discrimination.

4. Fees of children enrolled under RTE Rules as described in Condition: 3 will be released by the Government as per rules. So this Banning any fee from children.

5. Any capitation fee and voluntary donations prohibited by the school and school management from the parents.

6. Any form of collection during or after enrolment is prohibited. 6. The school / management body shall publish the information regarding the fee collected from the parents of the children in their school as tuition fee as per State Government Notification No: ED:31:PGC:2019, dated:27.07.2019 in the departmental website and on the school notice board. No fee shall be charged in excess of the prescribed fee.

7. The School / Management Board shall enrol the students within the period fixed by the Govt.

8. The School / Governing Body cannot refuse enrolment against the following points.

(i) Due to lack of age proof.

(ii) On the basis of caste, religion, place of birth, language.

(iii) If admission is sought after extended period of admission.

9. Carrying out all safety measures as per RTE Act and Rules, Karnataka Education Act and Rules. [Fire safety and building safety certificate from concerned authorities and child learning safety as per K.S.C.P.C.R and N.C.P.C.R).

10. The School / Governing Body is as follows

(i) in any class till the completion of primary education and secondary education of any admitted child in the school Not to be held back or expelled from school.

(ii) No child shall be subjected to physical or mental abuse.

(iii) No child shall be required to pass any board examination till completion of primary education

(iv) Every child who completes primary education is issued a certificate as prescribed under Rule 21 of RTE and the Karnataka Education Act and Rules.

(v) Special needs/special needs of the school as per provisions of RTE Act and Rules and Karnataka Education Act and Rules. Children with special needs should also be included. (vi) Teachers appointed under RTE Act and Rules and Karnataka Education Act and Rules and Government Orders Primary and High School teachers should possess the minimum qualifications as prescribed.

(vii) Salary and allowances payable to teachers and terms and conditions of service shall be as prescribed by the State Government. And salaries are paid to teachers through government notification [Prospective Fund (P)] and payable bank and other salaries and subject to Employee State Insurance (ESI)





(viii) Teachers Act Section 24[1] ; and perform the duties prescribed under the RTE Act and Rules and Rule 17 of the Karnataka Education Act and Rules and shall not engage themselves in private tuitions for supervisory considerations.

11. Adherence to the academic state curriculum and state text books to which the school is affiliated.
12. The school shall maintain rules and standards as specified in Section 19 of the Karnataka Education Act. Karnataka Education Act and appointing departmental staff as prescribed in the rules.
13. School buildings and other basic facilities associated with the school should not be given over to any commercial activities or political and non-educational activities during the day or night.
14. The school shall not be run for the benefit of any person or group or association.
15. Get the school audited by a Chartered Accountant and submit the copy to the Deputy Director / Field Education Officer by the end of June every year.
16. The School shall follow the Language Policy as per Government Notification [Kannada Language Policy 2016].
17. Governing body and teachers to act as per RTE Act and Karnataka Education Act and Rules.
18. The school / governing body shall strictly follow the rules and directives of the Government and the Department.
19. Mandatory uploading of school information in S.A.T.S. by the end of March every year.
20. Violation of the above conditions will result in the cancellation of the recognition of the school as per the rules framed under the RTE Act 2009 and the Karnataka Education Act 1983.
21. Complete document/information in the application submitted online by the Governing Body after completion of school accreditation process It will be made available for public viewing on the departmental website. 22. Violation of the above conditions will result in the cancellation of the recognition of the school as per the rules framed under the RTE Act 2009 and the Karnataka Education Act 1983.
